ELECTRONIC NOTICES (EMAIL)

The Sherwood Park Fish & Game Association will use email as the primary method of communication. Ensure your email is on file and that you consent to receiving broadcasts from the Association. REGULAR MEMBERSHIP

Regular Membership is for one person only. It allows participation in all Club functions and activities but does not allow Range privileges. It does allow use of the archery facilities. Regular Members are entitled to one vote at all General Meetings of the Association

FAMILY REGULAR MEMBERSHIP

Family Regular Membership consists of one Regular Member, a spouse or partner, and all dependent children under 18 years of age. Family Regular Membership allows participation in all Club functions and activities but does not allow Range privileges. It does allow use of the archery facilities. The Regular Member, the spouse or partner, and all dependent children 16 years of age and older are each entitled to one vote at all General Meetings of the Association.

RANGE MEMBERSHIP

Range Membership is for one person only. It allows participation in all Club functions and activities, including the use of the shooting ranges. Range Members are entitled to one vote at all General Meetings of the Association.

FAMILY RANGE MEMBERSHIP

Family Range Membership consists of one Range member, a spouse or partner, and all dependent children under 18 years of age. It allows participation in all Club functions and activities, including the use of the shooting ranges. Children under 18 years of age must be supervised by a Range Member. The Range Member, the spouse or partner, and all dependent children 16 years of age and older are each entitled to one vote at all General Meetings of the Association.

YOUTH MEMBERSHIP

A Youth Membership is open to young people under 18 years of age. A Range Member can purchase a Youth Membership for a brother, sister, nephew, niece or grandchild or for the child down the block who would like to use the shooting ranges. Children under 18 years of age must be supervised by a Range Member. Youth members 16 years of age and older are entitled to one vote at all General Meetings of the Association.

ANNUAL MEMBERSHIP FEES

- Memberships are from January 1st to December 31st of the current year in which the membership is purchased
- There is an annual membership fee for each Membership Classification
- The annual renewal deadline is November 30th
- Membership fees are established in accordance with the SPFGA Bylaws

ADMISSION OF MEMBERSHIP

Membership is available to any person who wishes to support the conservation of our fish, wildlife and natural resources and their management of the future and subscribes to the policies, principles, objectives and rules of the Association.

RIGHTS AND PRIVILEGES

A Member shall have the right:

- Of access to the property and facilities as provided by the membership classification
- To one vote on matters of the Association during General Meetings
- To become a Member of the Board of Directors if so elected by a majority at the Annual General Meeting or if appointed by the Board of Directors
- To receive communications from the Association.

OBLIGATIONS

- To comply with Association's policies
- To comply with Association rules as established by the Board of Directors published in the Policies Manual and/or posted on the Association's Recreational and Shooting Facilities.

WITHDRAWAL AND REFUND OF FEES

A member may withdraw from the Association tendering a written resignation to the Secretary of the Association, but the membership fee of such a member, or any part thereof, shall not be refunded except as approved by the Board of Directors.
